Terms and conditions:

1. Access to *Presit Skills Banks*; *Presit Mock Exams* and *Presit Online* exams is strictly based on and limited to one student per subscription / purchase.
2. Access to Presit is not permitted by friends family or acquaintances of subscribers or users. Presit reserve the right to suspend and /or cancel subscription to or use of Presit resources without refund should any abuse of usage occur.
3. We are the owner or the licensee of all intellectual property rights in our site and in the material published on it. Those works are protected by copyright laws and treaties around the world. All such rights are reserved. Questions, exam papers and images must not be modified in any way and illustrations photographs video or audio sequences or any graphics may not be used separately from any accompanying text. 4. Subscription to Presit Skills Bank is based on either **one calendar month –for the monthly subscription/ or 365 days -for yearly subscription. Users have clearly prescribed access to resources once purchased. This is stated in the instructions which can be downloaded as needed. Once purchased the access period begins. Please take note as this varies per product.**
5. Access to Presit Skills Bank is without daily limit, however **Presit operate and enforce a *fair usage* access policy. We would expect a user to attempt up to 400 *points per month. This amounts to approximately 85 to 90 points per week (based on a 52 week year). * N.B. Points are defined as any answerable sections / questions that sit within a numbered question - or within our database. Many of our numbered questions have subsections /questions and therefore tasks (questions) sit within these numbered questions. For example qu. 24 may have 6 subsections. This means that the total points available for question 24 would be 6 - even though it is listed as one question.**
6. Presit skills bank questions are written so that students experience a range of answer input requirements. We do this as it keeps our users' reading skills sharp. Some questions are multiple choice, others may be drag and drop. We are aware that schools reserve the right to alter their examination formats from year to year. Many of our students continue to use our resources post examinations also.
7. It is the parent's responsibility to ensure that your child is able enough to make fair use of the Presit resources. Presit accept no responsibility whatsoever for students who are unable to fairly attempt Presit's questions due to ability related issues. In addition Presit accept no responsibility for students who omit questions or do not pay careful attention to details within questions, such that these questions are effectively "wasted". In addition to rigorous compilation and preparation of our questions by seasoned professionals, Presit welcome feedback and queries by our customers and users to ensure that any issues encountered are readily addressed to benefit and enhance the experience of all of Presit's users.

We must also ask for the emergency mobile phone contact details of two responsible adults. We advise that you must either wait in the car at the venue or respectfully request that you do not travel to more than a 10 minute journey return time of the venue.
